Fellow in the spotlight: Shaun Fitzgerald – COVID transmission and risk exposure



Dr **Shaun Fitzgerald** (Director, Centre for Climate Repair at Cambridge and Fellow of Girton College) has just published a paper in *Building & Environment*, and entitled *Modelling uncertainty in the relative risk of exposure to the SARS-CoV-2 virus by airborne aerosol transmission in well mixed indoor air*, focusing on COVID transmission in different contexts, which received significant media attention.

In a nutshell and in Shaun's own words

"People might ask whether it is more risky going to work or going to the supermarket for example. If you keep your distance from everyone else, and completely avoid touching surfaces that are touched by others (or ensure you thoroughly sanitize your hands after touching a surface), the only viable transmission route you are subjected to is then the aerosol one. This paper presented an evaluation of the relative exposure (to SARS-Cov-2) for an individual in different environments, looking just at the aerosol transmission route."




